

TERMS AND CONDITIONS OF THE SCHEME

Unreserved acceptance of the following conditions is a requirement for participation in the seasonal touring scheme.

This scheme is strictly open to recreational touring customer only.

- For your security and safety, the owner must inform the park by completing a guest form each time anyone other than the registered owner of the touring caravan is going to use or occupy the seasonal touring pitch.
- NO GUESTS DOGS are permitted on the touring park, only owners dogs are permitted.
- If you intend to let your touring caravan to friends and family, then you are required to have an up to date and valid gas safety certificate, electric certificate and a portable appliance certificate.
- Passes will be issued for up to four members of any booking, an additional charge will be made if further passes are required.
- The pitch is offered on a seasonal licence basis only, touring caravan owners do not have any tenure rights.
- Winter storage is by separate agreement only, it is not included as part of this agreement.
- You are required to hold a valid insurance policy with Public Liability cover of at least £2 million in order to site the touring caravan on our site.
- You are required to send us a copy of your insurance copy before you first site your tourer.
- The site rules must be adhered to at all times. It is your responsibility as the caravan owner to ensure that your guests are aware of, and follow all site rules. Brynarian Park Ltd reserves the right to terminate this agreement without notice if the site rules are not followed.
- Brynarian Park Ltd has the right to re-site touring caravans in the case of an emergency.
- In the interests of safety, all awnings and windbreakers must be taken down when the caravan is not being occupied for any period longer than 14 nights.
- Groundsheets must be of the breathable variety and should be lifted at regular intervals to maintain the condition of the grass.
- In the interests of safety, only gas bottles that fit within the unit gas locker will be permitted whilst the occupier is not on-site.
- Only one vehicle may be parked by the touring caravan at any one time. Any other vehicle must be parked in the overflow car park. No commercial vehicles are permitted on-site.
- Brynarian Park Ltd accepts no responsibility for the loss or damage of any description, except when caused by negligence of Brynarian Park Ltd.
- The seasonal fee must be paid in full.
- The season runs from March to October.
- Termination - where the touring caravan owner seeks to terminate this agreement, the fee paid will be refunded on the following scale:
 - Termination before the end of May 40% repayment
 - Termination before the end of June 20% repayment
 - Termination after the end of June no repayment
 - Termination if this agreement needs to be notified in writing to reception
 - Termination by the park: no refund will be payable
